# Approved Consent Agenda -

McManus made a motion to approve the Consent Agenda to include the amended minutes from Council Meeting of June 9, 2020 and requesting the minutes from the June 11, 2020 Special Meeting; the Financial Report; pay bills in the \$42,006.54 and payroll in the amount of \$48,384.25.   - a. D. Delp made a motion to contract with Farrand Flat Work to continue replacing the west side sidewalk along Palmer Ave. not to exceed \$10,000.00. S. Craun seconded the motion.   - b. T. Whitford made a motion to have Gest Tree Services remove 4 trees and trim one tree: 462 Burr Oak Rd., 671 Willow Dr., 441 Maple St., 530 Maple St., 185 Palmer Ave.

  - c. The damage to the silver DPW barn from snow will need to be re-assessed. It may be just as cost effective to replace the existing structure on the existing concrete pad as to repair it. Jim will contact the insurance company. It was suggested to get a bid from Ware Construction.
- 2. Police report as presented.
  - a. M. McManus made a motion to allow Chief Brinkert and Billi Farrand to apply for First Responder Hazard Pay Premiums Program and any other Covid-19 grants or reimbursements. \$4,000 will be requested from the FRHPPP which will include \$1,000

for each full-time police officer and \$500 for each part-time police officer. If the grant is not received, Chief Brinkert will reimburse the payroll account \$4,000.00 from the Police Car Fund. D. - b. S. Craun made a motion to have K. Kuhlmann research financial institutions to give the best rate and terms on the water/sewer CD currently at Sturgis Bank and Trust. He will discuss it with S. Craun and B. Farrand before depositing the funds. He is authorized to deposit the funds at that time. T. Whitford seconded the motion. A roll call vote was taken. Yeas: S. Craun, D. Delp, E. - 4. Fire Board presented by S. Craun & M. McManus June minutes were presented.
  - a. The Board approved 8 radios at a cost of \$1,031.25.
  - b. There is In the checking account \$178,170.93; building savings account \$17,283.07; large equipment savings account \$59,962.79; rescue fund \$12,815.79. June's monthly bills totaled \$176.46. 34 calls were made for the month of June.
  - c. The Marathon donated a pop machine. The Shell will sell the pop to the Fire Department at cost. They discussed time frame to purchase the new fire truck
  - d. The bylaws are being rewritten.
  - e. 25 "800 Pagers" are being purchased at a cost of \$20,000.00.
- 5. Lake Board presented by Ed Bell
  - a. The water clarity has improved on Long Lake. Palmer Lake is still cloudy.
  - b. The Board had a public meeting Saturday, July 11<sup>th</sup> at 9:00 AM at the Colon Fire and Rescue building.
  - c. The Board has elected to have a one-year moratorium on taxes for 2020. A committee will reassess business,
  - d. A & E sprayed for milfoil in certain spots.
  - e. There is \$384, 804.12 in the Lake Board account.
  - f. Next meeting is set for August 8<sup>th</sup> at the Township Hall.

- C. Obstructions at the Public Lake accesses The Village Lawyer will be asked to draft a Cease and Desist order to be presented to the people who have blocked a public access.
- D. Well Head Protection E. LeBoeuf made a motion to apply for a \$4,000 grant to contract with Fleis and Vanderbrink for another year to help the Village with the Well Head Protection project. The Village's share of the contract with FV would also be \$4,000.00 for a total cost of \$8,000.00.
